The Pre-Meeting Conference of the City Council of the City of Vineland was called to order by the President, Paul F. Spinelli.

The Deputy Municipal Clerk stated Public Notice of this meeting, pursuant to the Open Public Meetings Act, has been given on December 11, 2019 by the City Clerk in the following manner:

2. Providing written notice to the offices of The Daily Journal and The Press of Atlantic City;
3. Filing written notice in the office of the City Clerk of the City of Vineland.

President Spinelli asked if anyone from the public would like to comment.

There being no one to be heard, the president closed the comment portion of the meeting.

The Deputy Clerk reviewed changes to the agenda since the January 7th work session. President Spinelli advised to removed Resolution 2020-15 that dealt with a collective bargaining agreement between the City and IAE Local R2-75 and was replaced with a settlement agreement per Solicitor Tonetta and taken out of consent. Ordinance 2020-02 was revised to add the #1-2020 Schedule. Resolution 2020-07 was revised on January 10th per Solicitor Tonetta. Resolution 2020-08 was added per Director Franchetta authorized by President Spinelli. Resolution 2020-14 was revised on January 8th to add 1 owner and 1 operator to the taxi cab licenses. Resolution 2020-23 was added on January 9th per Business Administrator Dickenson. There was a communication from the Mayor and Resolution 2020-24 added, both on January 10th, ratifying appointments to the Zoning Board. There was also a communication added on January 13th by Mayor Fanucci appointing Luigi Tramontana as Coordinator of the Office of Emergency Management.

There was a reminder by Business Administrator Dickenson that both the Landis Sewerage Authority and the Housing Authority are scheduled to deliver reports at the January 21st work session.

President Spinelli entertained a motion by Councilman Acosta, and seconded by Councilman Franceschini, to adjourn the meeting. The Clerk called the roll: YEAS: Councilman Acosta
